Greetings! We are looking forward to another great year this year. Be sure to get your application in before the April 20 deadline to be considered and accepted to this year's fair!

Rules of entry for food vendors at the Roseberry Arts and Crafts Fair:

2. Applications to serve food must be returned by **April 20, 2020**. Entrants will be notified by mail of acceptance ASAP after that date. Food vending spaces are limited, so send your **application early**. **The application must be complete to be considered.** We are really enforcing this.
3. **Entry fee is \$150.00**
\$15.00 late fee if postmarked after April 20, 2020.
4. Spaces will be pre-assigned. There is electricity available. If you have been to the fair before, please let us know where you would like to set up. Vendors who have been at the fair before will have preference to where they will be.
5. **No booth/table break-down before 4:30 PM Sunday July 5th.**
6. Please keep your area clean during the fair, and when the fair is over, please make sure your area is left clean. (There are dumpsters)
7. You are completely responsible for the security of your booth and its contents throughout the course of the fair. Keep in mind **the fair will be held outdoors, rain or shine: plan accordingly.**
8. You are also responsible for collecting, reporting & paying the Idaho Sales Tax (6%)
9. **All show fees must be paid at time of application.** If an applicant drops out after the deadline of **April 20**, only half of the entry fee will be returned and then only if we find a replacement. **No refund after June 1, 2020 except for medical emergencies.**

Set up: Starting at 2:00 pm Friday, July 3rd or 7:00 am until 9:00am, Sat. July 4th. Check in at the registration booth for space assignment & tax form.
